Fostering Self-Sufficiency In the East Bay, many families struggle to find jobs that provide a living wage For them, one illness or accident can send their family spiraling into crisis At Catholic Charities, our vision is to provide a continuum of care to help move families from crisis to stability to prosperity By providing rental and utility assistance programs, our Critical Family Needs program helped keep 364 families together and in their homes Through our Family Literacy Program, we helped 186 parents and children in North Richmond by providing adult education and ESL/literacy classes, parenting classes, child care, and parent and child interactive literacy classes

Welcoming the Stranger In record numbers, people from around the world are fleeing warfare, persecution and poverty They leave everything behind in search of a better, safer life Through our Immigration Legal Services, we helped 1,055 members of our community begin the journey towards citizenship, and provided legal consultation to 1,485 low-income immigrants The Refugee Resettlement Program welcomed 178 newly arrived refugees to their new home in the East Bay The Refugee Employment Program placed 145 clients in jobs with 74% retaining the job for 30 days or more We were able to instill a spirit of empowerment so that immigrants can be leaders in their home, community and work

Healing Trauma Families and children living in poverty in urban areas often suffer multiple traumas over many years At Catholic Charities, we counsel those who are afflicted by trauma and loss The Crisis Response Support Network (CRSN) and Victims of Crime Clinical Case Management Program served 44 impacted by crime and violence in their community, companioning them in their grief, and assisting them with urgent needs so that they may recover Our Restorative Trauma-Informed Practices Program For Schools (RTIPs) trains school personnel in restorative practices to address the root causes of harmful behavior and to consider options to repair harm done, helping to reduce suspensions by 69% in 11 schools The RTIPs for Teens Program provided mental health treatment and trauma counseling to 73 students experiencing multiple, ongoing incidences of trauma
